Key Follow ups and actions:

- **ESSENCE more relevant than ever:** To build on tremendous success of ESSENCE in bringing together members and stakeholders over the years to recommit to focus of the initiative and work together in a changing global health and global health research environment.
- <u>WGRI:</u> To further focus on specific activities, support WHO R&D Observatory and WorldReport components of the mechanism, engage new members in the work, enhance communication of the work to the members and beyond.
- <u>Health, Migration and Displacement:</u> To organise a webinar to understand funders' perspectives on this topic and how to address any challenges.
- IR WG: To send a survey in order to choose future priorities.
- RM WG: To develop a plan for enhanced collaboration with the RIMAs;

Notes of the ESSENCE Mechanism Meeting

Wednesday 19th - Thursday 20th February 2025

This was the fourth Mechanism Meeting. The aim was to demonstrate partnerships and investments to bring research and research tools forward. Different countries and partnerships presented their work and findings. LMIC funders shared their perspectives. Joyelle Dominique (NIAID) and Thabi Maitin (ESSENCE) chaired this half of the meeting.

Follow ups from these meetings:

- <u>African National Health Research Systems Barometer:</u> WHO AFRO to complete rollout of NHRS survey, track and reconfirm performance of National Health Research Systems.
- GIOPID-R to connect with ESSENCE, LMIC WG and WGRI and identify areas of collaboration.

- Ask for ESSENCE to coordinate research capacity strengthening to prepare for future pandemics
- 3 objectives: greater data access, greater research translation, greater research training coordination
- Plan to establish platform in order to improve coordination around research
- Possible interest in increasing research capacity in low-income settings

Part 2: Collaborative Funding for Science Diplomacy

- Joyelle Dominique: NIAID
- Importance of collaboration, connecting scientists, reducing barriers, and progression, building global research relationships
- Overview of IPK, answers for emergencies in Cuba
- NIAID and IPK shared interests established a foundation for collaborations
- End goal is that good science is important and can sustain partnerships to overcome barriers

Part 3: Funding agencies collaboration: Wellcome and Science for Africa Foundation (SFA)

- Clear criteria: operational communication aspects to benefit the relationship, reporting clear with objectives
- Challenge of reporting and discussion in terms of fine details: reports can be tough but SFA is learning; a basis of mutual respect, trust, accountability and openness, supports grown and listening form both parties.
- Overcome ego and continue with work with smaller opportunities. It is a balancing act to align and deliver.

Science Granting Councils Initiative

- Launched in 2015: 17 councils have gone through transformations. Growth through domestic funding and partnerships
- Recent example of programme: rethink use of platform of SGCs and develop health research
- Pilot initiative launched last year: develop mini research agendas, invest and match funds. Successful pilot exercise pan-African initiative innovation and vaccines

- Strengthen pandemic response faster, sustainable and bridging gaps
- Pandemic Pact: improve research response and preparation for future outbreaks
- Explore with LMIC Working Group and WGRI bring them together and assess what they have in common through joint meeting

Tools for Funders and Researchers: Global Observatory on Health R&D

Indicators of Impact on Global Health Funding

- Sarah Charnaud WHO
- Overview of tools
- Support health for all: specific priorities in specific products, similar priorities
- Monitor R&D, gather data on R&D, develop research priorities
- Data can be measured in different ways, different sources and databases
- Map biomedical research capacity based on available data

Overview of World Report

- Map of funding and grants, 22 funding agencies, available to everyone
- Researchers can identify funders, priorities, and other researchers for collaboration; funders can identify research capacity, other funders' interests, and regions with variable investment

Impact Global Health (presented by Sarah Charnaud)

- Infectious disease tracker
- Different ways of tracking impacts
- Interactive way of using the tools
- Monitoring funding towards research priorities on migration and health, monitor investments

- ESSENCE to add value of what could happen attempt to know who is planning to fund what
- Advocacy for importance of research and tools to capture gaps and opportunities

Part 6: Collaboration of Research Institutes in the Context of the Pasteur Network

- Climate and health are new to the Pasteur Network need support from policy makers
- Budget: focus on covering all costs, salaries. Overheads are often too low and not accepted by donors, not viable can be stopped by political decisions
- Organisations may not be aware of what other organisations are doing in a similar space. How do you track and can you collaborate?

Part 7: African National Health Research Systems Barometer

- Constance Assohou-Luty WHO AFRO (online)
- First assessment in 2018, second in 2020, strengthening national research capacity, aim to repeat survey in 2025
- Barometer scores decline indicates need for interventions and improvement of existing research support systems
- Devise a tool to assess NHRS and track performances, guide and capacity-building initiatives
- NHRS survey is currently being rolled out in all 47 countries in the African region questionnaire updated to include impact of COVID on systems and continuing research strengthening
- Invitation of survey help from ESSENCE members different aspects that may be pointed out

<u>Tools for Funders and Researchers: Pandemic PACT: Tracking Research Funding and Evidence for Preparedness and Response</u>

- Alice Norton GloPID-R (online)
- Demonstration of tool tour of the website led by UKCDR and GloPID-R, including up to date COVID funding data
- Other tools: funding across all health research but specifically pandemic preparedness and responserelated topics
- Funding data during COVID was easy as most funders were sharing and it was publicly available on funders' web sites. There are now limitations of clinical trials data and other funding data.

Reflections
